Rich Taylor, Frank Levings, Floyd Scott and Jim Oblizalo—finished second in the standings.

Jim Smalling continued as the league's top bowler with a 213 average. Bud Rogers posted the year's biggest improvement, increasing his average from 160 to 179.66. Darren Simonds had the year's highest scratch game with 288, while Jim Happs posted the best handicap game at 313. Jim Smalling nailed a 755 scratch series to top that listing; Steve Eason had the highest handicap series at 808.

We also give awards for the highest game over average in three age groups. Division A (over 80 years old) was won by Floyd Scott with a game 100 pins over average. Division B (70-79 years old) went to Ritchie Carlson with a game 90 pins over average. Division C (under 70 years) was topped by Bob Clanton with a game 92 pins over average.

Individual bowlers received pin money for wins over the course of the season. Overall, we handed out over \$7,000 in prize money!

In more bowling news, many of our bowlers made the annual trip to Carson City for the SIR tournament there. The lanes were tricky—most of us struggled a bit to sort out the best line. Money winners at Carson City included Don Baldwin/Tom Page, fourth in Division 2 doubles, Ritchie Carlson/Joe Bowers, 13th in the same event, Darren Simonds, 12th in Division 1 All Events, and Don Baldwin, 21st in Division 2 All Events.

Local bowling will continue with several informal leagues over the summer at Country Club Lanes, including no-tap bowling on Fridays at noon. In July, I will hand out sign-up sheets for our 2019-2020 league. I hope to see our bowlers from this year return and many new bowlers sign up to participate in the bowling fun.

The continuing saga of how dangerous the game of Golf is ...

I have previously shared stories of how dangerous golf is—what with Alligators in Florida, a shark in the water at a course near Brisbane, Australia and then there was the golfer who LITERALLY bit off the thumb of another golfer is Plymouth, Massachusetts.

WELL—Here we go again: This time it happened at 8:30 AM on the 7th hole at the Mohegan Sun Golf Course on Dows Lane in Baltic, Connecticut, when a bobcat attacked a golfer—who ended up being transported by ambulance to a nearby hospital. "It jumped on his back, but he was able to fight it off with a golf club. He thought it was dead, but as he walked a few steps away it ended up jumping back up and taking off on him, chased by another member of the golfer's team." said Sgt. Chris Dwyer. [See—those clubs have MANY, MANY uses, besides just throwing into the water on a bad day! / Ed.]

Following the incident, The Connecticut Department of Energy & Environmental Protection's (DEEP) Environmental Conservation Police managed to locate the bobcat and humanely euthanized it, according to officials. The animal was taken to UConn Medical Lab where it tested positive for rabies, they added. The animal is also being eyed in an attack on a horse earlier in the morning, officials said. The horse is under the care of a veterinarian after it was cut on its neck and eye.

"This is the first time I've ever even heard of this. It's very unfortunate, unusual," said Philip Krick, general manager of Mohegan Sun Golf Club.

When the attack happened, everyone was brought off the course immediately.

Bobcats are normally shy secretive animals and attacks on humans are extremely rare. The last reported incident in Connecticut was in Bozrah in late August, 2014. That animal also tested positive for rabies.

I keep telling you guys, Golf is WAY TOO dangerous! What is next? A grizzly? Elephant stampede? Who knows!
