DUES PAYMENT

1. At the November BEC meeting a motion was made to implement a \$25.00 annual mandatory dues structure beginning January 2022. The motion was seconded and all BEC members present voted in favor of the motion, none opposed.
2. Policy 30 in SIR manual states: Branches may raise funds through dues or voluntary contributions as approved by the BEC.
3. After 4 months delinquency, those members will be contacted by a BEC member or a committee as designated by the BEC.
4. If after 6 months termination may be instituted by the BEC if desired. Exceptions can be made for members with financial problems, out of state or serious sickness in family or for any reason deemed reasonable by the BEC. This is allowable under Policy 26 in SIR manual which states: A Branch Executive Committee may terminate a member for a serious breach of a State Procedure, Bylaw, or Branch Regulation.

1. **Eligibility:** Active SIR Members, those with SIR membership applications pending, guest of a SIR member (man or woman 50 years or older), wives of SIR members regardless of age, widow of a SIR. All entrants must be USBC sanctioned bowlers for the current season.
2. **Participation:**
 - a) **Singles:** A bowler may bowl only one time
 - b) **Doubles:** A bowler may bowl and cash twice. At least one bowler in the lineup must be different. **ONE BOWLER MUST BE A SIR MEMBER**
 - c) First score bowled in each event will count for **All Events** prize.
3. **Handicap:** 100% of 230 singles; 460 doubles
4. **Average: HIGHEST OF:**
 - a) 2020-2021 USBC Standard Composite Average or Current SIR Bowler Tournament Average (SBTA), as posted one week prior to the tournament;
 - b) If none use USBC 2019-2020 Standard Composite Average;
 - c) If none, use highest current league average of 21 games or more (must supply secretary-signed current league sheet at check-in);
 - d) If none, bowler shall use 230 average (NO HANDICAP).
5. **Verification:** If averages (per this Tournament Rule 4) are on the USBC website (Bowl.com) or the SIR website, no further verification is required. Averages and USBC membership will be checked prior to start of tournament.
6. **Divisions:** There will be two divisions: Divisions 1 and 2 will be divided by average after mail-in close of entries.
7. **Prize Fund:** Will be returned 100% on a ratio of at least 1 prize for each 4 entries.
